

Privacy statement and terms of use

The tourism marketing information system TourMIS (www.tourmis.info) is an online information system of the Modul University Vienna GmbH that contains statistical information on economic, demographic, social, ecological and cultural issues of national and international tourism development, to the interest of the general public.

User data and usage information

The use of the tourism marketing information system TourMIS is in principle free, but only under disclosure of name, gender, e-mail, preferred language of communication and user-group. Additional user data arise when user create forum entries or when they, upon request and under certain circumstances (qualification), receive special entry rights, which allow them to enter data and to become agents of statistics.

As a producer of data in TourMIS the system will reference its originators by name. In addition, entries made by users in forums and queries will be stored in the TourMIS database. The statistics entered by users, the information on the usage of the system and the user data is used for access control, for communication between users, for statistical purposes, for website optimization and to improve the information offer of TourMIS. Usage information and user data will only be stored on the server of MODUL University Vienna GmbH. Usage information or user data will not be made available to third parties. Usage information in TourMIS is pseudonymised before it is stored and processed. TourMIS does not use cookies.

Optionally, users can sign up for mailings about current and relevant TourMIS information (*newsletter*). Users can always decide to unsubscribe the TourMIS newsletter by disabling the newsletter checkbox in *Edit user profile* available in the main menu.

The use of TourMIS without storage of user data and usage information is not possible. Users give their consent to the terms of use during the registration process which explicitly requires the above mentioned user data and usage information. MODUL University Vienna GmbH has pointed out that user can revoke their consent at any time with immediate effect. A revocation is possible in the area *Edit user profile*, which leads to a deletion of all user data and has the effect that a user must register again if he/she wants to continue using TourMIS.

Data security

User data will be stored on servers from MODUL University Vienna GmbH protected by access control and firewall. User data is only accessible by authorized users and computers. MODUL University Vienna GmbH secures its online information system TourMIS through technical and organizational measures against loss, destruction, access, modification or distribution of user data by unauthorized persons.

TourMIS consists of statistics of various sources which are presented in tables and graphs. If the contained material is accurately reproduced and the original source is quoted it is permitted to reproduce, distribute, make publicly available and process the content.
